New construction	\$0.22 per square foot including basement each floor, and roof
Alteration	\$0.22 per square foot of affected area, or 1.1% of the total construction costs as estimated by the Building Official, whichever is greater
Fire code review of plans	10% of building permit fee, in addition to building permit fee (\$50.00 minimum)
Permit / Plan Revision - after ISD plan review approval, per revision	50% of original permit fee (maximum \$2000.00), per revision
Investigation of work without a permit	\$300.00
