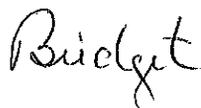
Dear Dr. Neuman,

This letter is in response to your above referenced letter requesting clarification of the difference in the amount of loans reported on or before January 15<sup>th</sup> 2016 and the amount reported in the most recently submitted Annual Campaign Fund Report for the 2015 Election, received by the Board of Supervisors of Elections ( the "Board" ) on November 6<sup>th</sup> 2018.

No loans have been repaid or forgiven. Upon review, we have discovered that commencing with the first Annual Campaign Fund Report for the 2015 Election, submitted on November 7<sup>th</sup> 2016, the total reported was \$1,900.00 and should have been \$1,960.00. We can only speculate that the cause of this was a clerical error when completing the form.
