Maryland Road to Recovery Information

On May 6, 2020, Governor Hogan announced the preliminary roadmap for the path to re-opening following the Coronavirus outbreak. **It is important to note at this time that Maryland is still following the stay at home orders that the Governor issued in late March.** Be aware that the Montgomery County Executive Marc Elrich may issue orders to extend the stay at home orders for the county for the health and safety of all residents. State of Maryland: Stay at Home & Face Coverings Orders

As of March 30, 2020, Governor Larry Hogan issued a stay at home order for all residents of Maryland. Below are the guidelines for citizens to follow related to the new orders. On April 18, 2020, the governor extended this order to include the mandatory use of face coverings for citizens who are participating in commercial activities throughout the state.

- **Face coverings must be worn by everyone participating in:**
 - Riding public transportation
 - Entering an enclosed retail space or food service establishment
 - Retail staff are required to wear face masks
 - Food Service staff who interact with customers
 - Adults are required to cover the faces the children age 2-9 as much as possible

- **Exercising outdoors** is still permitted if it does not violate social distancing and restrictions regarding gatherings of 10 or more.
- **Out-of-State Travel - No Marylander should be traveling outside of the state unless such travel is necessary. Those who have traveled outside of the state should self-quarantine for 14 days.**
- **All Travel should be limited to necessary trips only** - This means that all travel should be limited to:
 - Grocery, takeout meals, and prescriptions travel
 - Travel to seek medical treatment or emergency services
 - Travel to and from work only if your position has been deemed essential.
- **Penalties.** - This order is to be enforced by state and local law enforcement. Knowingly and willfully violating this order is a misdemeanor, and on conviction, offenders may be subject to imprisonment not exceeding one year or a fine not exceeding \$5,000 or both.

COVID-19 – Basic Safety Tips

Social Distancing

- **Maintain 6 feet of space between you and others.** This includes others inside your home.
- **Reduce visits to friends and family**, and when possible change visits to video and phone calls
- **Gatherings of 10 or more people are still prohibited** under the State of Emergency Guidelines.

Protecting Yourself

- **Wash your hands** often with soap and water for at least 20 seconds especially after you have been in a public place, or after blowing your nose, coughing, or sneezing.
- If soap and water are not readily available, **use a hand sanitizer that contains at least 60% alcohol.** Cover all surfaces of your hands and rub them together until they feel dry.
- **Avoid touching your eyes, nose, and mouth** with unwashed hands.
- **Avoid close contact** with anyone who is sick.

Protecting Others

- **Stay home** if you are sick, **except to get medical care.**
- **Cover your mouth and nose** with a tissue when you cough or sneeze or use the inside of your elbow.
- If you go out, make sure to use a face covering.
- **Throw used tissues** in the trash.

It is to be noted that the words “arrested” and “charged” do not imply guilt.
