Download the Lyft app and enter the DECEMBERSAFEDC in the app's 'Promo' section for up to \$15 off one ride taken home in the D.C. coverage area until New Year's Eve and, after 9:00 p.m. on December 31, you may visit [SoberRide.com](https://www.SoberRide.com) for a new code.
