Accomplishments for FY23 (July 1, 2022 – June 30, 2023)

- Conduct Courtesy Reviews in a timely fashion to provide potential applicants with feedback on their project(s).
- Review and recommend Montgomery County Tax Credit applications.
- Kickoff the update of the Historic Preservation sections of the Zoning Ordinance.
- Review and provide comment for West End Design Guidelines.
- Review and provide comment for Lincoln Park Design Guidelines.

Public Education and Outreach Activities

- Update Historic Preservation webpages to better provide information in a clear and concise way.
- Research and gather information for developing historic signage panels for King Farm Farmstead.

- Update application forms for the Historic District Commission.

HDC Administration/Staff Actions

- Kickoff implementation of Action Steps identified in the *Historic Preservation Work Plan* for FY 2024 which may include:
 - o Prepare a codification of existing zoning code for preservation regulations.
 - Prepare zoning text amendment for local designation and associated designation criteria.
 - o Prepare zoning text amendment addressing administrative-level COA process.
 - o Prepare zoning ordinance addressing delisting of locally designated properties.
 - o Prepare zoning text amendment regarding parties of interest and owner consent.
 - Prepare zoning text amendment to strengthen existing property maintenance code for historic building or develop new ordinance section for demolition by neglect.
 - Research and gather input on potential local incentive program(s).
 - o Gather input on creating a local easement/protective covenant program.
 - Examine ways to expand public outreach in relation to municipal historic preservation.
 - Assist with the coordination of outreach for below-grade resources off city property.
- Review and provide comment for Section 106 Program as referrals come in.
- Perform assessment of the Avery Road Colored Cemetery and Benjamin Smith Homestead sites through various non-destructive means to confirm the existence of any below grade resources.
