City Hall Opening Delayed Following Surge in COVID-19 Cases

Rockville will delay reopening City Hall following a surge in COVID-19 cases driven by the new, more infectious omicron variant.

The Mayor and Council discussed the delayed reopening at their Monday, Dec. 20 meeting. City Hall was set to reopen Monday, Jan. 3. The Mayor and Council will revisit the discussion at their Monday, Jan. 10 meeting.

"A vaccination against COVID-19 and a booster shot, as well as covering up with a face mask, are still the best defense against the virus," City Manager Rob DiSpirito said. "If you have not yet been vaccinated, I encourage you to do so as soon as possible in the interest of your health and that of our community."

City staff and the Mayor and Council continue to review city protocols as health guidance and conditions evolve daily, and will adjust requirements for city facilities as needed.

According to the Centers for Disease Control and Prevention,

the omicron variant, which accounted for less than 1% of cases at the start of December, now accounts for about three-quarters of new COVID-19 cases in the U.S.


Maryland's seven-day positivity rate was at 10.27%, the highest it has been since January 2021, according to the Maryland COVID-19 Data Dashboard at coronavirus.maryland.gov.

City Hall has been closed since March 14, 2020, in an effort to protect the health of Rockville employees and the public, and prevent the spread of COVID-19. City government remains open with employees reporting on-site, in the field or virtually. The city's virtual services can be accessed through www.rockvillemd.gov.

Rockville employees are required to be vaccinated against COVID-19 and to have received booster shots, unless exempt for religious or medical reasons. Employees with approved exemptions are required to undergo mandatory weekly COVID-19 testing. The policy covers temporary, part- and full-time employees who work on-site and remotely.

The city is also pausing its recreational youth basketball program, and will continue to follow the advice and actions of the county's health department.

They are: cleanups of a trail at Croydon Creek Nature Center; a Weed Warrior activity; creating care kits for new immigrants and refugees; a self-guided neighborhood cleanup; making blankets for sick children, scarves for families in need and handmade crafts for children in need; and writing thank-you notes for seniors. Rockville Celebrates Fifth Year of Full Marks for LGBTQ+ Support

For a fifth consecutive year, and for the 10th anniversary of the Human Rights Campaign's Municipal Equality Index, Rockville has scored perfect marks for the city's commitment to the health, welfare, safety and equality of its lesbian, gay, bisexual, transgender and queer community.

Rockville scored a perfect 100 out of 100, plus an additional 10 bonus points, for its nondiscrimination laws, law enforcement, employment and workplace inclusivity, leadership, and services to the LGBTQ+ community.

"So much of this progress has

been fueled by municipalities leading with equity, inclusion and respect," HRC Foundation interim president Joni Madison states in the report's introduction. "These city leaders understand that when LGBTQ+ residents and visitors are welcomed and embraced, this helps their entire municipality thrive."

The 10th annual MEI scorecard, released in November, analyzes and rates 506 municipalities across the country, measuring each for the inclusivity of laws, policies and services for their LGBTQ+ communities.

This year, the cities rated in-

clude the 50 state capitals, the 200 largest cities in the U.S., the five largest cities or municipalities in each state, cities home to the state's two largest public universities, 75 cities and municipalities that have high proportions of same-sex couples, and 98 cities selected by HRC and Equality Federation state group members and supporters.

Ranked cities comprise more than 94.2 million in population.

Cities are rated across numerous criteria, covering citywide nondiscrimination protections, policies for municipal employees, city services, law enforcement and

the city's leadership on LGBTQ+ equality.

Snow How: Be In-the-Know About Winter Weather

Quick Links, Facts and Phone Numbers

When winter weather strikes, turn to the city's website at www.rockville md.gov.

Closure and snow emergency information will be available on the website, as well as through Facebook (www.facebook.com/cityof rockville) and Twitter (@ rockville411), and by signing up for Alert Rockville notifications at www. rockvillemd.gov/alerts.

City crews treat and plow roads in priority order. First are primary roads, including major arterial roads, emergency routes, central business districts and primary residential roads near schools. Next are secondary roads, including the remainder of neighborhood streets, alleyways and cul-de-sacs. To check if an address is within the city limits, find the Address and Residency Check map at www. rockvillemd.gov/maps.

This snow season, the city is again urging patience on the part of residents as operations and normal service times may be impacted due to the COVID-19 pandemic. Crews will respond as quickly and safely as possible.

Removing snow from sidewalks, driveways and entrances is the responsibility of the property and/or business owner or a community association. Rockville requires that snow and ice be removed from sidewalks, steps, driveways, parking spaces and similar paved areas for public use within 24 hours after a snowfall of up to three inches, within 48 hours after a snowfall of three to 10 inches, and within 72 hours after a snowfall of more than 10 inches. If residents can do so, they should clear snow from around fire hydrants and storm drains. To report a sidewalk that has not been cleared within the required timeframe, call 240-314-8330.

Residents are encouraged to check on older neighbors who may need assistance clearing snow. See the article on this page about the city's volunteer snow shoveling for seniors.

Grant Program Seeks Projects to Improve Communities

Applications Are Being Accepted

The city's matching grant program helps neighbors work together to accomplish common goals that support the health, vitality and inclusivity of the place they call home.

Community Empowerment Matching Grant applications are being accepted through Friday, Feb. 4. Approved grants will become available Wednesday, March 9.

Neighborhood, civic or homeowners associations, community groups, organized groups of neighbors and student groups are eligible to apply. Neighbors and organizations willing to match funding through cash, in-kind donations and volunteer hours are also eligible.

Applications are reviewed and grants are awarded by the City Manager's Office.

Grants typically range from \$500-\$1,000 each, must benefit a clearly identified area within city limits and may address any or all of the following objectives:

Building community: Projects that promote the development or sustainability of a neighborhood association or community group. Activities that foster diversity, equity and inclusion.

Community improvement projects: Projects that improve the shared space within a neighborhood or strengthen community identity. City Legislative Priorities: Legal Notices, Schools, Fighting Climate Change and Protecting Homes

Maryland General Assembly's 90-Day Session Begins Jan. 12

Rockville's 2022 state legislative priorities include authorization of electronic legal notices, education funding, protecting homes and businesses from the state's project to widen Interstate 270, and combating climate change.

The 2022 state legislative session runs from Wednesday, Jan. 12-Monday, April 11 in Annapolis. Under priorities approved by the Mayor and Council on Nov. 1, the city will advocate for:

- Jurisdictions to be allowed to post electronic legal notices. With no local print newspapers in Montgomery County, Rockville is forced to post costly print notices in "The Washington Post."
- Increased state aid for school operations and construction to support education from birth through community college.
- No Rockville homes, businesses or infrastructure to be taken by the state's I-495 and I-270 Managed Lanes Project.
- Noise barrier projects for all communities impacted by the Interstate 270 project.
- Climate change policy initiatives including, but not limited to, climate resiliency, flood plain planning and resilience, community choice aggregation for energy purchasing, electric vehicle incentives, and renewable energy.
- Increased funding for senior transportation services, recreation and wellness programs, senior programs in neighborhoods, aging-in-place and village initiatives, and outreach to increase awareness of these services and programs.

- An increase in the fine for illegally modified vehicle exhaust systems that generate excessive noise and disrupt the quality of life in neighborhoods.
- \$250,000 for renovations to the F. Scott Fitzgerald Theatre and Social Hall to comply with the Americans with Disabilities Act.

Rockville is also supporting two Maryland Municipal League-backed priorities:

- Full and permanent restoration of municipal Highway User Revenue funding, beginning in Fiscal Year 2025. This share of state fuel and vehicle taxes is distributed to local governments for road and bridge maintenance. Fiscal Year 2022 is the third year of a five-year state budget restoration of aid to a level that is approximately 85% of what it was before the 2008 recession. The state estimates Rockville will receive \$2.6 million in aid in FY 2022. about 78% of the pre-recession level of \$3.3 million.
- A revision to state law so that municipalities have the option of creating their own police accountability board and administrative charging committee.

The Mayor and Council on Dec. 20 discussed these priorities with the District 17 delegation, which represents Rockville in the General Assembly. Mayor and Council Adopt Fee Increases to Cover Development Costs

The Mayor and Council voted Dec. 6 to increase development fees across the board by an average 2.5% to address increased expense from development-related city services and the cost of new efficiency-oriented technology.

Building fees were last updated in 2018. Development fees have remained unchanged since 2011. The new fee structure will go into effect Monday, Feb. 7.

Building fees consist mainly of building and trade-related permits, nonbusiness licenses, fire safety permits and life safety reviews on new commercial buildings, additions and alterations, as well as occupancy permits.

A new sign variance fee will cover costs associated with changes in the sign ordinance adopted in 2019. A new fee for minor commercial developments will cover the cost of review and notification for this new, expedited process.

Minimum electrical permit and residential alteration fees were increased to slightly higher rates, aligning them with other similar permit fee types. Some adjustments to the structure lowered fees for certain services. For example, residential solar panels and electric-vehicle charging fixtures and outlets fees were reduced by roughly 50% to encourage installation.

Fees will also change for public works development-related permits, either directly or as reflected through 2.5% increases to the Department of Public Works' standard prices for cost estimating, which is used to determine bond and fee amounts. A new fee for fire hydrant flow testing will cover the cost of service provided by city crews.

Residential parking fees, which haven't been adjusted since 1985, will be raised from \$2 a year to \$5 a year.

FY 2021 Financial Reports Highlight Rockville's Finances

Two annual reports released last month give the public a closer look at Rockville's financial health during the most recently completed fiscal year.

For Fiscal Year 2021, which closed June 30, the city ended with an overall net position of \$307.1 million, an increase of 4.7% over last year, City Manager Rob DiSpirito wrote in the city's Popular Annual Financial Report, a summary document highlight-

ing the city's finances. Net position is a useful indicator of a government's financial health and represents total assets minus total liabilities.

"The change in net position is based on increases in property tax revenue, coupled with conservative spending across City departments and programs," DiSpirito wrote.

Recycling the Holiday Season

When the post-holiday cleanup begins, remember: Rockville collects and recycles electronics, such as cell phones, computers, televisions and holiday lights through requests for special collections, and collects Christmas trees as part of its recycling and trash collection.

Place trees at the curb for pickup on regular recycling and trash collection days after removing all ornaments and metals, wires, stands and decorations, including tinsel. Trees should not be bagged. There is no deadline for curbside collection of trees. (Note that the Montgomery County Recycling Center, which formerly converted the trees into mulch, no longer offers this service.)

Artificial trees should be placed in the gray trash cart for regular weekly collection. Artificial trees that are too large to fit in the cart can be collected by appointment, as one of six bulk collections allowed per year, or taken to the transfer station.

Getting rid of old batteries? Don't dispose of them in your trash or recycling cart, where they could start a fire. Instead, bring batteries of any size to the household hazardous waste drop-off at the county transfer station at 16105 Frederick Road.

For batteries larger than 9 volts, including rechargeable batteries found in phones, laptops and power tools, cover the terminals with packing tape or duct tape and place them in a plastic bag or container, separate from batteries that don't require being taped.

Pesticide Law Applies — So Don't Apply Weed and Feed

The new year brings a new law regarding lawn care in Rockville.

The Mayor and Council voted in April to allow Montgomery County's pesticide law to apply in the city, effective Saturday, Jan. 1. The law restricts the use of certain pesticides on private lawns, playgrounds, mulched recreation areas and child care facilities, prohibiting most synthetic pesticides.

Environmentally Friendly Removal Tips

Walking in a winter wonderland can be wonderful. But it can also prove hazardous. Follow these tips to keep your sidewalks and driveway snow- and ice-free, while minimizing the environmental impact:

Shovel Early, Shovel
Often: Removing fresh
snow before it has a chance
to harden into ice is the best
way to keep your pavement
clear. Deicers work best on
thin layers of snow or ice that
need to be melted, so shovel
first, break up any ice patches
you can and then add the
salt.

Apply Salt Sparingly: Scatter the deicer and leave space between the grains. A 12-ounce coffee mug full of salt is enough to treat a 20-foot driveway or 10 sidewalk squares. Using more than the recommended amount of salt won't speed up melting but can harm soil and water quality.

Buy Early and Check
Labels: Buy your deicing
product before the big storm,
so you don't end up staring at empty shelves in the
stores. Check the label before
you buy — although slightly
more expensive, calcium
chloride (CaCl2) requires less
salt, works at lower temperatures and does not contain
cyanide, unlike sodium chloride (NaCl, also known as



Accurate and timely inspection reporting, combined with a new capacity for tracking, will reduce false alarms and expedite fire protection system repair, while helping to ensure a greater ability to save lives and protect property in the

Baltimore Road Reopens as Improvement Project Continues

Baltimore Road has reopened to vehicle and pedestrian traffic between Gladstone and Broadwood drives as construction continues to improve safety and access along the corridor between Rockville Town Center and the city's east side.

The road had been closed between Gladstone and Broadwood drives since June while a city contractor replaced the roadway culvert at the stream crossing near Rockville Cemetery, relocated water lines, installed storm drain connections and restored the stream.

Contractors completed base paving, sidewalk installation and restoration on Baltimore Road between Denham and Woodburn roads last month. They previously installed drainpipe and inlets, new curb and gutter, and pervious sidewalks along the roadway between First Street and Woodburn Road.

Crews continue to install new sanitary sewer along westbound Baltimore Road, on the roadway's north side, between Woodburn Road and Edmonston Drive. Relocating the sewer, which is designed to avoid conflicts with the proposed storm drain, is expected to be completed by the end of January. Project progress is dependent on weather and supply-chain issues, which delayed the reopening of the previously closed segment of roadway.

Storm drain and sidewalks between Woodburn Road and Edmonston Drive will be installed during a future phase of the project. Residents will be notified before that work begins. Roadway resurfacing will be one of the final steps of the project, which is expected to be completed in spring 2022.

Rockville and Shady Grove Metro Stations to Reopen Jan. 16

Metro's Rockville and Shady Grove stations will reopen Sunday, Jan. 16 after a four-month shutdown to repair and replace the stations' aging canopies, Metro announced.

During the closures, Metro demolished the canopy at the Rockville station, erected a new steel canopy structure, and made improvements that include installation of new information screens, brighter lighting, modern fare gates, higher-quality announcement speakers and new closed-circuit television cameras. The Park and Ride has been repaved for safer, more accessible parking. At Shady Grove, the platform canopy, roof and escalators are being repaired, and modernized fare gates are being

Parking remains available free-of-charge, but is limited, at the Shady Grove and Rockville stations while the stations are closed. Free shuttle buses are being provided during the closures, connecting the Shady Grove, Rockville and Twinbrook stations. The Twinbrook station remains open. Red Line trains are operating between Twinbrook and Glenmont at normal service levels.

While the stations will be open in January, the canopies will provide cover for customers but will remain temporarily unfinished until Metro determines the best type of exterior cladding needed to complete the project, it

fund reserve of \$22.9 million, equal to 27% of the total general fund, which is the main source of funding the city's day-to-day

The city maintains a triple-A bond rating. Triple-A is the highest possible rating and saves Rockville taxpayers money by allowing the city to borrow at the lowest possible interest rates.

The city created the first PAFR in 2007 to explain, in layman's terms, the information

contained in Rockville's recently renamed Annual Comprehensive Financial Report, which DiSpirito presented to the Mayor and Council on Dec. 20. The ACFR is prepared by the Finance Department in accordance with generally accepted accounting principles, and is audited by certified public accountants.

The FY21 PAFR describes:

- City government and services.
- The city's financial structure, including governmental funds, such as the general fund, capital projects fund and

enterprise funds.

- The overall financial health of the city.
- The city's capital investments and debt.
- Property taxes and utility rates, including how to read tax and utility bills.

rock salt). Urea is sometimes promoted as lawn-friendly, as excess urea will act as a fertilizer. However, the application rate for urea is far greater than your lawn would require, and most of the excess urea will only end up fertilizing the stream.

Avoid Kitty Litter and Ashes: While these products are environmentally friendly, they are only marginally effective at adding traction and won't melt ice. If you need traction, a better option is to mix in a small amount of sand and use less salt.

Charter Review Commission Has Some Questions About City Elections

Online Questionnaire and Town Hall Meeting to Gather Community Input

Rockville's Charter Review Commission will use an online questionnaire, and is planning a town hall meeting, to gather community input about how to improve city elections for all.

While the next City of Rockville election is not until 2023, the Charter Review Commission is asking Rockville residents to start thinking about how to increase voter turnout, update the city's election process and engage more communities. About 70% of registered voters in Rockville did not vote in the city's 2019 election.

The questionnaire presents a unique opportunity to share thoughts with the commission and help create meaningful change for the next decade. The commission will use the responses to inform its ongoing work and is planning a town hall meeting later this winter. Watch the city's webpage and social media for details.

Yard Waste Collection Update

Staffing shortages are causing delays in weekly yard waste collections throughout the city.

The city is working to bring staffing levels back to where it can once again resume regularly scheduled collections. We understand the importance of routine yard waste collections during this season and are making every effort to provide this service. We apologize for the inconvenience and appreciate your patience.

Place yard waste in bio-

degradable paper lawn bags or 32-gallon trash cans (the weight must be less than 50 pounds) in a safe location at the curb, so that crews can collect it as soon as possible.

Do not remove yard waste if it has not been collected and do not move items back and forth. Having yard waste at the curb will help crews assess collection needs and make plans to catch up as soon as possible, including collecting on Friday and Saturday. Mayor and Council to Continue ARPA Discussion, Seek Budget Input

The Mayor and Council continue their work on the Fiscal Year 2023 budget in January and are scheduled to vote on how to spend some of Rockville's portion of funds received through the federal American Rescue Plan Act.

ARPA's goal is to aid state and local governments in recovering from the budgetary, economic and financial impacts of the COVID-19 pandemic. On Dec. 13, the Mayor and Council directed staff to apply \$1.1 million of the city's \$9.6 million in ARPA funding to sewer and electrical infrastructure for the King Farm Farmstead, \$533,000 to the recycling transfer station at the city's Gude Drive Maintenance Facility, and \$300,000 to cybersecurity for the city's water treatment plant. They are scheduled to vote Monday, Jan. 10 to finalize the spending plan for that portion of the federal aid. A work session on Monday, March 21 will focus on how to apply the remaining \$3.8 million in ARPA funding.

In October, the Mayor and Council directed staff to apply nearly \$3.9 million in ARPA funding toward water infrastructure improvements and assisting city water and sewer customers in paying past-due utility bills incurred during the pandemic. New water and sewer rates and a new rate structure, adopted

November, take effect on Jan. 1.

A budget survey, on the webpage in English and Spanish, allows community members to identify their top budget priorities, initiatives for reducing the negative impacts of COVID-19 and options for maintaining a balanced budget. The public response to the survey will provide valuable input to the Mayor and Council for their FY23 budget discussions.

The Mayor and Council's upcoming budget process for FY 2023, which begins July 1, includes:

- Monday, Feb. 28: A presentation of the city manager's proposed FY 2023 operating budget and Capital Improvements Program.
- Monday, March 7: Public hearing.
- Monday, March 21: FY23 budget public hearing, and work sessions on the budget and the use of ARPA funds.
- Monday, April 4: Public hearing.
- Friday, April 15: Close of budget public record.
- Monday, April 18: Work
- Monday, April 25: Final direction on FY23 budget.
- Monday, May 9: Adoption of the FY23 operating budget and Capital Improvements Program.
- Friday, July 1: FY23 begins. 💠
