Ordinance No. 19-10

ORDINANCE:

To amend Chapter 23, "Traffic" by amending Section 23-25 so as to amend the provisions restricting parking during snow emergencies

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF ROCKVILLE,

MARYLAND that Chapter 23, "Traffic" be amended by amending Section 23-25, "Snow emergencies" to read as follows:

Sec. 23-25. Snow emergencies.

- (a) When a winter storm is predicted for Montgomery County, the City Manager, at his discretion, may, by public announcement invoke snow emergency parking restrictions for as long as may be necessary. Immediately upon such declaration, it shall be unlawful to park or leave any vehicle on the street if the resident has a driveway to park vehicles. If driveways will not hold all vehicles or if the residence does not have a driveway, then parking will be allowed only on the even numbered side of the street. If the residence is located on a court or cul-de-sac and the residence has no driveway to park the vehicle, then the vehicle must be parked away from the bulb portion of the court or cul-de-sac. If the residences are not numbered even and odd on the court or cul-de-sac, then all residents must park their vehicles on the left hand side of the street as one enters the court or cul-de-sac. If the there is no space on the court or cul-de-sac, then all vehicles must be parked on the even side of the first adjoining street.
- [(b) [Upon cessation of the snowfall and clearance of the roadway on the odd-numbered side of such residential streets, vehicles shall be moved from the even-numbered side to the odd-numbered side of the streets, in order to permit clearance of snow from the even-numbered side.]
- [(c)] (b) The City Manager and his designated agent or agents may remove and impound any vehicle parked[, stored or left] in violation of this section, and keep the same impounded until the owner thereof, or other duly authorized person, shall deposit collateral in the amount and in the manner provided for in case of violations of this chapter and shall have paid to the City Clerk or to the towing company an amount equal to the towage and any and all reasonable storage charges incurred by the City in impounding the vehicle.
