To grant Street Closing and Abandonment Application No. SCA2020-000107, Grove Rockville 31 II, LLC c/o Lantian Development LLC, Applicant

WHEREAS, Grove Rockville 31 II, LLC, c/o Lantian Development LLC, the owner of the LOT 6, DANAC Technological Park Subdivision, filed application No. SCA2020-000107, requesting that a small section of unimproved right-of-way along Choke Cherry Road abutting LOT 6, DANAC Technological Park Subdivision, in Rockville, Maryland, containing 705 square feet of land, more or less, lying in the City of Rockville, Montgomery County, Maryland, be permanently closed and abandoned pursuant to the provisions of Chapter 21, Article III, Division 2 entitled "Permanent Closing and Abandonment," of the Rockville City Code; and

WHEREAS, Grove Rockville 31 II, LLC c/o Lantian Development, LLC, is the only owner, according to the assessment records, of property adjacent to this public right-of-way, which is the subject of the aforesaid application, and all public utility companies authorized by the Public Service Commission to operate within the City of Rockville, were duly notified by certified mail that said application had been filed and that a public hearing thereon would be held as specified in the public advertisement of the Mayor and Council of Rockville, Maryland; and

WHEREAS, the Mayor and Council of Rockville gave notice that a public hearing on said application was held by the Mayor and Council of Rockville in the Council Chamber, Rockville City Hall, 111 Maryland Avenue, Rockville, Maryland on November 18, 2019 at 7:00 p.m., which notice was published not less than ten days prior to the time of such hearing in a newspaper of general circulation in the City of Rockville; and

WHEREAS, on November 18, 2019, said application came on for hearing at the time and place provided in said advertisement; and

WHEREAS, based upon the testimony presented and other evidence of record in the proceedings, the Mayor and Council determined that there is no public need for the subject right-of-way and the granting of the application would not adversely affect the health, safety, security and best interests of the community of the City of Rockville.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND COUNCIL OF ROCKVILLE, MARYLAND, as follows:

- 1. That Street Closing and Abandonment Application No. SCA2020-000107, for the closing and abandonment of a section of unimproved right-of-way along Choke Cherry Road, in Rockville, Maryland, containing 705 square feet of land, more or less, being more fully described in Exhibit A, be and the same is hereby granted.
- 2. That this ordinance shall become automatically effective upon the last of the following to occur:
- a. Approval of the applicant's Site Plan that pertains to the area containing the abandonment by the City of Rockville
- b. Written confirmation from WSSC that the 8-inch water house connection within the area to be abandoned has been abandoned pursuant to WSSC's Development Service Code.

c. The recordation of this ordinance in the Land Records for Montgomery County, Maryland by the City Attorney's Office.

- 2.) 100.61 feet along the arc of a non-tangent curve deflecting to the right, having a radius of 368.30 feet and a chord of South 46°14'03" East, 100.30 feet to a point of tangency; thence
- 3.) South 38°24'30" East, 4.77 feet to a point on curve number 5 as shown on the aforementioned plat recorded in Plat Book 79 as Plat 7975; thence running with and along said curve
- 4.) 1.92 feet along the arc of a non-tangent curve deflecting to the right, having a radius of 60.00 feet and a chord of South 14°30'23" West, 1.92 feet to a point;
