RESOLUTION:

To establish the rate and schedule of monetary contributions for storm water management pursuant to Chapter 19 of the Rockville City Code

WHEREAS, Section 19-12 of Chapter 19 of the Rockville City Code, authorizes the Mayor and Council of Rockville to establish by resolution the rate and schedule of monetary contributions for stormwater management; and

WHEREAS, the purpose of the public stormwater management (SWM) program is to help safeguard the natural resources of the City; and

WHEREAS, this SWM program is funded by developer contributions when it is determined to be in the City's best interest to accept contributions in lieu of certain on-site SWM requirements; and

WHEREAS, contributions are based on the amount of imperviousness in the proposed development, which affects the magnitude and quality of disruptive forces of stormwater runoff on the receiving stream channels from the total site or any part thereof; and

WHEREAS, the Mayor and Council adopted Resolution No. 16-02 on September 9, 2002 to provide for water quality measures and to adjust the rate to an amount sufficient to cover the costs of the facility to be provided under the provisions of Chapter 19 of the Rockville City Code; and

WHEREAS, it is necessary to amend the schedule of stormwater management contributions established by Resolution No. 22-85, as amended by Resolution Nos. 4-86, 23-88, and 16-02 so as to revise and adjust the rate of monetary contributions to the City in lieu of providing on-site stormwater management to an amount sufficient to cover the costs of the facility to be provided under the provisions of Chapter 19 of the Rockville City Code.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF ROCKVILLE, MARYLAND, that the rate and formulas to be used to determine the monetary contributions to be made to the City in lieu of providing on-site stormwater management is hereby established as follows:

SCHEDULE OF STORM WATER MANAGEMENT CONTRIBUTIONS

- (1) The total amount of contribution shall be based on the following formulas for three separate categories entitled (a) Quality Contributions; (b) Quantity Contributions; and (c) Quality and Quantity Contributions.
 - (a) Quality Contributions.

Where a monetary contribution in lieu of on-site stormwater management water quality control (i.e., Water Quality Volume, including Recharge) is accepted, the following formula will apply:

$$C = Ai \times $12.000 12,300$$

- (b) Quantity Contributions.
- 1. Where a monetary contribution in lieu of on-site stormwater management quantity control for both Channel Protection Volume and Overbank Flood Protection Volume is accepted, the following formula will apply:

$$C = Ai \times $40,000 41,000$$

2. Where a monetary contribution in lieu of on-site stormwater management quantity control for only the Channel Protection Volume OR only the Overbank Flood Protection Volume is accepted, the following formula will apply:

$$C = Ai \times $20,000 20,500$$

(c) Quality and Quantity Contributions.

Where a monetary contribution in lieu of on-site stormwater management for both water quantity and water quality control is granted, the following formula will apply:

 $C = Ai \times $52,000 53,300$

(d) With respect to the sites involving more than one drainage area, the appropriate formula will be applied to each drainage area.

C – Contribution in dollars

Ai – Number of acres of proposed impervious surfaces as specified in the City's Sediment Control and Stormwater Management Regulations rounded to the nearest hundredth of an acre (including new and existing impervious areas) including one-half of the widths of the adjacent rights of way up to 30 feet maximum of existing and planned contiguous non-State streets and also State owned rights-of-way where storm water management has not been, or will not be, provided.

AND BE IT FURTHER RESOLVED, that this resolution shall become effective on September 1, 2021.
