Resolution of the Mayor and Council of Rockville adopted pursuant to Article XI-E of the Constitution of Maryland, Sections 4-303 and 4-304 of the Local Government Article of the Annotated Code of Maryland, and the Charter of the City of Rockville to amend Section 1 of Article VIII, "Personnel," of the Charter of the City of Rockville so as to delete the provision that the City Clerk also be the Treasurer; to add the title "Director of Council Operations" to the City Clerk title; and to provide that the City Clerk shall have authority over all personnel matters in the City Clerk's office.

Section 1. BE IT RESOLVED BY THE MAYOR AND COUNCIL OF ROCKVILLE, MARYLAND, that Section 1 of Article VIII of the Charter of the City of Rockville be amended to read as follows:

ARTICLE VIII

Personnel

Section 1. Clerk to the Council.

The Council may appoint a Clerk, who shall also be [Treasurer,] the Director of Council Operations, (referred to as Clerk or City Clerk), and shall serve at its pleasure and at such compensation as it shall determine. The Clerk shall attend all meetings of the Council, keep a full and accurate account of its proceedings, and shall keep such other records and perform such other duties as may be required by this Charter or by the Council. Notwithstanding anything to the contrary in this Charter or the City Code, the City Clerk shall have authority over all personnel matters in the City Clerk's Office including, but not limited to, the management, classification, reclassification, supervision, hiring, suspension and removal of any employee in the City Clerk's Office.

Section 2. AND BE IT FURTHER RESOLVED that the date of the adoption of this Resolution is July 13, 2015, and that the amendment to the Charter of the Mayor and Council of Rockville hereby proposed by this enactment shall be and become effective on September 1, 2015, unless a proper petition for a referendum hereon shall be filed as permitted by law. A complete and exact copy of this Resolution shall be posted in City Hall until August 22, 2015, and a fair summary of this Resolution shall be published in a newspaper of general circulation in the City of Rockville not less than four (4) times, at weekly intervals before August 22, 2015.

Section 3. AND BE IT FURTHER RESOLVED that as soon as the Charter amendment hereby enacted shall become effective, either as herein provided or following a referendum, the Mayor and Council of Rockville shall send separately, by certified mail, return receipt requested, bearing a postmark from the United States Postal Service, to the Department of Legislative Reference, the following information concerning the charter amendment: (1) the complete text of the Charter of the Mayor and Council of Rockville as hereby enacted; (2) the date of the referendum election, if any, held with respect thereto; (3) the number of votes cast for and against the question concerning the Charter amendment, whether by the Council of the Mayor and Council of Rockville or in a referendum; and (4) the effective date of the Charter amendment.

Section 4. AND BE IT FURTHER RESOLVED that the Mayor of the Mayor and Council of Rockville is hereby specifically enjoined and instructed to carry out the provisions of
