WHEREAS, Beryl L. Feinberg served the citizens of Rockville for the past ten years and has distinguished herself as a Councilmember through her integrity, strength, wisdom and leadership; and

WHEREAS, Beryl L. Feinberg initiated the creation of the Caregiver Task Force with resulting changes to how grants are awarded, and she served as Board Chair of Montgomery Hospice and served on the Board of the Montgomery County Collaboration Council for Children, Youth and Families; and

Feinberg is responsible for bringing forward the Minority-Female-Disabled informal technical assistance and procurement program, and she brought forth the City's Project Search participation in the program to provide differently-abled young adults job experiences and work life skills, followed by the City's commitment to identify one funded position for a Project Search graduate or differently-abled young adult; and

WHEREAS, Beryl L. Feinberg was responsible for the implementation of the fraud line and ongoing funding for internal performance audits.
