RESOLUTION: To provide for public hearing in connection with the annexation of 4.032 acres of land, more or less, of 355 Partners, LLC

- 6.) North 52° 50' 41" West, 345.14 feet to the point of beginning containing 175,627 square feet or 4.03184 acres of land.

WHEREAS, the signatures for said petition have been verified and it has been ascertained that the persons authorizing said petition are the owners of twenty-five percent (25%) of the assessed valuation of the real property located in the area to be annexed and that there are no residents or registered voters on the property to be annexed; and

WHEREAS, pursuant to the provisions of the Local Government Article, Division II, Title 4, Subtitle 4, "Annexation" of the Annotated Code of Maryland, a resolution has been introduced which, if adopted, would annex the additional property referenced herein, which property is more particularly described in said resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF ROCKVILLE, MARYLAND, as follows:

- 1. That the City Clerk is instructed to cause a public notice of the resolution which has been introduced which, if adopted, would annex property of 355 Partners, LLC to be published not fewer than two times at not less than weekly intervals in a newspaper of general circulation in the City of Rockville and the area to be annexed, said notice to specify that a public hearing will be held on the resolution in the office of the Mayor and Council at 7:00 p.m. or as soon thereafter as it may be held, on the 16th day of November, 2015, in the Council Chamber, Rockville City Hall, 111 Maryland Avenue, Rockville, Maryland 20850.
- 2. That the City Clerk is instructed to provide a copy of the Annexation Plan for the area proposed to be annexed to the County Executive of Montgomery County, Maryland, the Secretary of the State Department of Planning and the Chairman of the Maryland-National Capital Park and Planning Commission at least thirty days prior to the holding of the scheduled public hearing.
- That immediately upon the first publication of the public notice of said resolution, the City Clerk is instructed to cause said public notice to be provided to the County Executive of Montgomery County, Maryland, Secretary of the State Department of Planning and the Chairman of the Maryland-National Capital Park and Planning Commission.
