WHEREAS, it is a condition of the issuance of an erosion and sediment control or stormwater  
management permit by the Department of Public Works of the City of Rockville, Maryland,  
acting for and on behalf of the City, (the "**Permit**") that these presents should be executed.

NOW, THEREFORE, the condition of this obligation is such that the Permittee and its agents and servants will:

1. Faithfully complete the construction and installation of any required erosion and sediment control measures, including stormwater management, within the period of time specified in the approval of the application of which they pertain;
2. Comply with all applicable ordinances and requirements of the City, the District, and the Water Resources Administration, and the Maryland Department of the Environment;
3. Indemnify and save harmless the City from all expenses, damages, claims and actions arising from or relating to the performance or nonperformance of the work required of the Permittee, its agents, employees or subcontractors under the Permit and applicable laws and regulations; and
4. Forfeit any and all portions of its bond or other securities to satisfy unpaid fines or penalties owed for violations of Chapter 19 of the Rockville City Code, and to reimburse costs incurred by the City to correct violations if reasonable efforts to correct the violation or to remit the fine have not been undertaken.

This obligation shall remain in full force and effect until the work described in the application has been approved by the City Manager of the City of Rockville, Maryland, and/or until the City receives a stormwater management contribution pursuant to the provisions of Chapter 19 of the Rockville City Code, provided, however, that the City reserves the right to require the design and construction of an on-site stormwater management system in lieu of a contribution.
