Occupancy - per 5,000 square feet or fraction thereof	\$175.00
Amendments – third and subsequent reviews	50% of original permit fee or \$175.00, whichever is greater (maximum \$2,430.00)

Automation Fee (Charged on all permits, in addition to permit fees)	10.25% of all permit and application fees.

### Fire Alarm and Detection Systems

Fire alarm devices - More than three (3) devices (with or without main control panel)	\$175.00 first four (4) devices, plus \$25.00 per device above four (4)
Walk-Thru Permit: for three (3) devices or fewer	\$89.75

### Water-based Fire Protection Systems

Fire Sprinkler, foam, combined standpipe and water mist systems (10 or more heads)	\$175.00, plus \$7.25 per head, nozzle, or applicator
Walk-Thru Permit: for nine (9) heads or fewer	\$89.75

Other equipment not specifically covered, including gas connections	Each appliance
